STL filed a detailed reply seeking refusal of enforcement of award, however, the Court on 5 Jun 23 allowed ShinEtsu's Petition and ordered that the said arbitral award dated 24 Feb 21 is enforceable and executable as a decree of this Court. On 4 Sept 2023, STL filed a Special Leave Petition (SLP) before the Supreme Court challenging the Bombay High Court's Order dated 5 Jun 23.</li> <li>On 24 Nov 2023 the Supreme Court has dismissed the SLP filed by STL.</li> </ul>
